Election: Direct Primary Election held on June 3, 2008

SUMMARY INFORMATION – POST-ELECTION MANUAL TALLY pursuant to California Elections Code 15360 and Condition 21 of the "Withdrawal of Approval of Sequoia Voting Systems, Inc., WinEDS v 3.1.012/AVC Edge/Insight/OpTech 400-C DRE & Optical Scan Voting System and Conditional Re-Approval of the Use of Sequoia Voting Systems, Inc., WinEDS v 3.1.012/AVC Edge/Insight/OpTech 400-C DRE & Optical Scan Voting System (October 25, 2007 Revision)".

1. Precincts were randomly selected on June 5, 2008 @ 11:35am by rolling of various multi-sided die. The precinct to fully tally was selected by dividing the 140 election precincts (in numerical order) into seven groups of 20. An eight sided die was rolled to select a group. A twenty sided die was rolled to select the precinct within that group. The precincts for the remaining contests were selected by separating the precincts into ballot type (numerically), deleting the ballot type for the precinct to be fully counted, and then rolling a thirty sided die to select a precinct within each remaining ballot type.
2. Manual tally for polling place ballots and vote by mail ballots was initiated on June 5, 2008 and completed on June 9, 2008. The manual tally was conducted daily by two teams of five from 8:00am to 5:00pm until it was concluded.
3. Two discrepancies were found in the polling place ballots and vote by mail ballots manual tally. The machine tally for Paul R. Singh, Democrat for State Assembly, was 36 and the hand tally was 37 for a variance of 0.067%. The machine tally for Wally Herger, Republican for Congressional Representative was 60 and the hand tally was 61 for a variance of 0.037%. Both candidates ran unopposed with no qualified write-in candidates.
4. The 100% manual tally of Edge VVPAT's was conducted on June 9, 2008 through June 11, 2008 for eight hours per day by two teams of five until completed.
5. There were no discrepancies between the manually tallied VVPAT records and the corresponding electronic vote results.
