1% POST ELECTION MANUAL TALLY

In accordance with the California Election Code, the Santa Clara County Registrar of Voters conducted a manually tally of precincts for the Presidential General Election on November 4, 2008.

- The 1% Precincts were randomly selected using a computerized random number generator on November 5, 2008 at 12:30 p.m.
- The 1% Post Election Manual Tally was conducted from November 12 – November 24th.
- The Manual Tally was performed on 21 polling place precincts, 21 vote by mail precincts and 9 mail ballot precincts. The canvass teams counted one contest at a time added the votes received and compared the totals with the reports from the 400C Tabulating Machine Report.
- Any discrepancy that was found was resolved in the 1% Post Election Manual Tally
- A list of the precincts tallied is attached.
