SUMMARY INFORMATION – POST-ELECTION MANUAL TALLY pursuant to California Elections Code 15360 and the Emergency Regulations: Post Election Manual Tallies in the California Code of Regulations sections 20120, 20121, 20122, 20123, 20124, 20125, 20126 and 20127 of Chapter 3, Division 7 of Title 2.

1. Precincts were randomly selected on May 19, 2009 @ 2:45pm by utilizing our DFM Election Management System random precinct selection application. While only one precinct was required to be manually tallied (1% of 51=1), two precincts were selected to be manually counted in their entirety.
2. Manual tally for polling place ballots and vote by mail ballots was initiated on May 22, 2009 and completed on May 27, 2009. The manual tally was conducted daily by one team of nine including one supervisor from 8:00am to 5:00pm.
3. A breakdown by precinct and a summary of discrepancies and variances is attached to this report.
4. One ballot did not get tallied by the Sequoia 400C Optech Scanner, which caused six variances. The other four variances were caused by improper marking by the voter and were picked up as undervotes. The results were not changed to reflect these discrepancies.
5. The 100% manual tally of Edge VVPAT's was conducted on May 20, 2009. One Edge was used in the office and no votes were cast on it.
6. Undervotes are reflected in the attached reports. However, no overvotes were tallied because all overvoted ballots were separated (and not counted) by the Sequoia 400C Optech Scanner for further examination.
