Dear Mr. Ikonomakis,

On Thursday, August 21, 2025, the California Secretary of State Office of Voting Systems Technology Assessment (OVSTA) received requests for administrative approval for five (5) modifications to the Dominion Democracy Suite 5.19 voting system pursuant to California Elections Code section 19216. The modifications are as follows:

California Elections Code section 19216 precludes a voting system or part of a voting system that has been approved by the Secretary of State from being changed or modified until the Secretary of State has determined the change "does not impair its accuracy and efficiency...."

If the Secretary of State determines whether the change or modification does not impair the accuracy or efficiency of the voting system, the Secretary of State may administratively approve the proposed change or modification.

In addition, you submitted the following document from Pro V&V:
